## COVID-19 Safety Acknowledgement Form

The following COVID-19 Safety Protocols have been developed in response to the ongoing COVID-19 pandemic. These procedures are designed to promote safety and mitigate risk of transmission while supporting the need to continue in-person activities on campus.

### I understand and will comply with the following COVID-19 requirements for summer camp.

- Carroll Community College will require all people over the age of 2, regardless of vaccination status, to wear a well-fitted mask inside our facilities and in crowded outdoor settings to reduce the spread of the COVID-19. This includes Summer Camp check in & pick up.
- The College follows and requires adherence to the latest CDC protocols on [isolation and quarantine](#).

### I will not bring my child to camp if any of the following apply\*:

- My child is ill or has had a positive PCR, Rapid or Home test for COVID-19\*\*; or
- My child has had [Close Contact](#), defined by the CDC as “someone who was within 6 feet of an infected person for a cumulative total of 15 minutes or more over a 24-hour period, starting from 2 days before illness onset (or for asymptomatic patients, 2 days prior to test specimen collection) until the time the patient is isolated,” regardless of whether cloth face coverings were worn.
- We have received a call from a Health Department or any other Contact Tracer about my child being exposed; or
- My child has a temperature reading of 100.4 or higher or has other COVID-19 [symptoms](#)

\*If any of these circumstances apply, my child may return in-person to campus only once cleared by: **Dr. DaVida Anderson**, the College’s Director of Student Care & Integrity. Her email is [danderson3@carrollcc.edu](mailto:danderson3@carrollcc.edu). *In some instances, you may be required to provide a release note from your child’s healthcare provider.*

\*\* *At the recommendation of the Carroll County Health Department, the College does not accept negative results from Home Tests regardless of vaccination status. Negative Rapid Test results will be accepted for fully vaccinated individuals.*

Additionally:

- It is **recommended** that you discuss your plans for your child attending camp this summer with your child’s healthcare provider.

- **The College is following and requires adherence to the CDC's guidance on all travel.** If your child plans to travel domestically (in the United States) or internationally, please notify **Dr. DaVida Anderson**, the College's Director of Student Care & Integrity, [danderson3@carrollcc.edu](mailto:danderson3@carrollcc.edu) in advance so appropriate plans are in place upon their return.
