## E. Household Income/Tax Return Information

As part of the verification process we are required to verify the tax information provided on your FAFSA application. Below are your options for providing this information:

1. Log back into your FAFSA application, click on the Financial Information tab and use the IRS Data Retrieval Tool (DRT) to link your taxes. Make sure to save and submit the application. This will link your tax return, but not your W2s, 1099s or Schedule C. This process will provide us your information within 3 to 5 business days. **-or-**
2. Visit IRS.gov and print a copy of your **TAX RETURN TRANSCRIPT (not an account transcript)**. If you cannot print out a copy, you can request a copy be mailed to you. This process takes 5 to 10 business days. **-or-**
3. Call the IRS at 1-800-908-9946 to request a copy of your **TAX RETURN TRANSCRIPT (not an account transcript)** to be mailed to you. This process takes 5 to 10 business days.
