Enrollment

- First year start Fall 2026 - Practical Nursing (PN) and Registered Nursing (RN) students
- Maximum enrollment is 80 students
- Second year start Summer 2026 - RN Completion Practical Nursing to RN, Paramedic to RN, Military Medica to RN
- Maximum enrollment is 15 students

Application Process

- The following documents must be submitted together as a single application packet:
 - Application
 - Signed and dated
 - Recommendation Form
 - Use only the recommendation form on the website
 - Must be signed
 - Only include two
 - Do not have to be sealed
 - Copy of Driver's License (we will not do this for you)
 - Copy of Proof of CNA (if applicable)
 - Proof of Graduation from High School
 - Official Transcripts
 - OTHER than Carroll Community College
 - Complete Transfer Evaluation Request form - located in Lynx Student Portal, under Carroll Forms
 - You do not need to re-submit any transcripts already sent to the records office

Entrance Exam: NLN-NEX

- NLN-NEX is only entrance exam score accepted for admission in this nursing program
- The NLN-NEX is required for ALL applicants
- This test must be taken on our campus, we will not accept scores from remote proctors
- The exam **MUST** be successfully completed by February 15, 2026. The minimum composite score accepted is 138.
 - Students are eligible to re-test every 30 days
 - A proctoring fee of \$25 will be charged for all re-tests in addition to the cost of the exam (\$53 for first attempt and then \$78 for any additional attempts)
 - Please pay the testing center on your re-testing day
 - Bring a photo ID

Admission Point System

- Students must score a minimum of a composite score of 138 on the NLN-NEX **AND** a minimum of a 2.5 GPA in prerequisite courses for their application to be considered
- Science courses BIOL 210, 211, & 215: Points will be awarded for each of these courses. 3 points for every A, 2 for B's, and 1 for C's.
- ENGL 101 and Math 115: 2 points for each A, 1 for B's, and 0.5 points for C's
- NO points for D or F grades
- Carroll County Resident= 3 points. No points awarded for students from other counties
- CNA certification from CCC or CCCTC = 2 points, CNA certification from elsewhere = 1 point.
- Transfer courses with grades **will** be included and will be assigned points based on the earned letter grades. Transfer credit earned without a grade (CLEP, AP, military evaluation, or challenge exams) **will not** be assigned quality points or calculated in the GPA.

Completion Points



Three points are awarded for completing all degree requirements by **February 15th** of the year you plan to begin in the program



Two points are awarded for plans to complete the degree requirements of the program by **May 31st** of the year you plan to begin



For example, if you apply to begin in Fall 2026, you will receive three points if all degree requirements (including all prerequisite courses) are completed by February 15, 2026. You will receive two points if all degree requirements are planned to be completed by May 31, 2026.

Point System



Repeating any BIOL prerequisite course will result in a ½ (one-half) point subtracted



Repeating more than one BIOL prerequisite course will result in a one-point deduction for each repeated attempt



If in ours, or a previous nursing program, before this admission and a grade of a D or F was awarded for any clinical nursing course, one point will be subtracted for every course with an unsuccessful score



Re-taking courses with C's or better to improve grades, **will not have points deducted.**



21 points is the maximum possible awarded points



Minimum points needed for admission change each term based on the pool of qualified applicants

Additional Admission Information

- If any accepted student declines their seat in the program, does not attend mandatory orientations, or fails to meet course requirements, the next eligible student on the waiting list will be offered a seat. This offer will be made via a phone call.
- If you are enrolled in courses at another college during the current semester, you must provide the Nursing Program with a copy of your current course schedule for the appropriate point value to be assessed.
- Once grades have been posted, transcripts for those students accepted conditionally will be re-evaluated. Any student who dropped a course or failed to earn a "C" or better, will no longer be eligible for admission into the program.

Additional Admission Information

- **After students are admitting into the nursing program, they must have:**
 - A physical by a healthcare provider
 - Demonstrated laboratory evidence of immunity for measles, mumps, rubella, and varicella
 - Proof of completion of Hepatitis B series or a signed waiver
 - Updated immunization for tetanus and pertussis
 - Annual seasonal flu immunization
 - No evidence of active Tuberculosis (TB), must be updated annually
 - Current cardiopulmonary resuscitation (CPR) certificate for healthcare providers (**The only accepted CPR is BLS-American Heart Association- Healthcare Provider**)
 - Proof of enrollment in a hospitalization insurance plan
 - Complete a criminal background check and urine drug screening
 - MUST test negative for marijuana use- even if you have a medical card

The program will provide more information regarding these requirements after accepted into the program

Maryland Board of Nursing

- The Maryland Board of Nursing may deny a license to any applicant who has been convicted of, or who pleads guilty or nolo contendere, to a felony or crime involving moral turpitude.

- Once accepted to our nursing program, you will have a mandatory orientation session in April.
- At this time, we will have all our partner institutions there and you can then begin an application process with them.
