## Introduction

HES-112, Health Care in the U.S., is a new course offering in the Health and Exercise Science area as of Fall 2022. The course was offered previously through the Health Information Technology program. This course-level assessment provides insight into how students performed on the assigned task for each course objective. Table 1 below provides the course objective and assessment methods, including the assignment task, proficiency measure, the number of students who achieved the task, and the equated percentage. There were 13 students enrolled who completed the course. This is a preliminary course assessment for improvement purposes. The course will be offered again in the 2023 fall semester.

## **Results Analysis Brief**

- A lower percentage of students achieved proficiency on the quiz short-essay responses than the other assigned writing tasks. These were direct questions found in the readings. The quizzes were timed but open-book.
- More than 84% of the students completed the discussion post tasks proficiently.
- About 85% of the students could produce an essay-style report or summary on most topics, but 61 84% used appropriate references to support their provided information.

## **Improvement Strategies**

- Review the quiz time logs to see how long students took for the short-essay questions.
- Offer more reference examples for the essay-style tasks.
- While not assessed, provide APA-style resources and tutorials for selecting credible references and how to write the citations.
