

**HONORS PROGRAM AGREEMENT APPENDIX BETWEEN  
CARROLL COMMUNITY COLLEGE  
AND  
ST. MARY’S COLLEGE OF MARYLAND**

This Honors Program Agreement (the “Agreement”) is made and entered into on August 5, 2024, by and between Carroll Community College (Sending Institution) and St. Mary’s College of Maryland (“SMCM”, Receiving Institution). St. Mary’s College of Maryland enthusiastically welcomes students from the Pappalardo Honors Program, STEM Scholars Program, or Carroll Lynx Scholars at Carroll Community College into our community of learners at the National Public Honors College.

**A. Provisions of the Agreement Appendix**

1. As stated in the Master Transfer Agreement signed on July 31, 2024, students who complete the Associate of Arts, Associate of Science, or the Associate of Arts in Teaching with a minimum cumulative grade point of 3.2 or higher are guaranteed admission to St. Mary’s College of Maryland.
2. Students who complete the Pappalardo Honors Program, STEM Scholars Program, or Carroll Lynx Scholars at Carroll Community College will receive an application fee waiver. In order to receive the application fee waiver, the student must submit proof of enrollment in the Honors Program at Carroll Community College at the time of application.
3. Students who complete the Pappalardo Honors Program, STEM Scholars Program, or Carroll Lynx Scholars at Carroll Community College with a minimum cumulative grade point average of 3.5 or higher will be eligible for a Honors scholarship up to \$2,000 at SMCM.
4. In order to be eligible for these benefits, students must submit the PTK/Honors Verification Form to St. Mary’s College of Maryland at the time of application.
5. Carroll Community College and SMCM designate the following representatives as their primary contact for the Honors Program participants:
