

**CARROLL COMMUNITY COLLEGE
AND
YORK COLLEGE OF PENNSYLVANIA
GUARANTEED ADMISSION
AGREEMENT**

York College of Pennsylvania (YCP) welcomes students from Carroll Community College (CCC) into our community of learners. The Guaranteed Admission Transfer Agreement is designed to facilitate Carroll Community College students' ease of transfer to YCP.

Under this Agreement, CCC students graduating with any CCC Associates degree will be eligible for the Guaranteed Admissions program.

QUALIFICATIONS FOR THIS AGREEMENT

Students interested in the Guaranteed Admission program are encouraged to consult with their dedicated advisor at CCC and the Assistant Director of Transfer Admissions at YCP to assist in choosing courses which will meet the requirements in the declared major. Transcripts will be evaluated on a preliminary basis by a representative from the YCP Admissions Office prior to application upon request.

OBLIGATIONS OF THE PARTICIPATING TRANSFER STUDENT

1. Submit the YCP Application for Admission at least six months prior to the start of the semester he/she wishes to transfer to York College of Pennsylvania.
2. Satisfy all other YCP admissions requirements, which are available on the College website at www.ycp.edu or by contacting an admissions counselor at York College of Pennsylvania.
3. Graduate from CCC with a minimum cumulative grade-point average (GPA) of 2.0.
4. Recognize that grades of "C" or better will transfer.
5. Understand that anyone outside of 35 miles must live on campus. Students who are part of this agreement and reside outside of 35 miles but wish to commute can be reviewed on a case by case basis by the Vice President of Enrollment Management.
6. Understand that YCP will accept up to 75 transferable credits from a community college.
7. Understand that students with at least 60 transferable credits will enter with junior status.
8. Understand that if they were previously enrolled at YCP, they are not eligible for this agreement.
9. Submit CCC transcripts along with transcripts from any other colleges they may have attended prior to attending CCC.
10. To benefit from the Guaranteed Admissions program, students must enroll in YCP within one year of graduating from Carroll Community College without attending another institution of higher education.

OBLIGATIONS OF YORK COLLEGE OF PENNSYLVANIA

To facilitate the transfer of CCC graduates to YCP in accordance with the foregoing, YCP agrees to the following:

1. To invite CCC students to information sessions at YCP
2. Those students entering full-time study at YCP are eligible to be awarded academic merit scholarships (click on *Transfer Merit Scholarships*).
3. To ensure that incoming students will be provided with YCP financial aid information and receive full consideration for YCP financial aid, in addition to appropriate scholarships and grants listed above, upon matriculation at York College.
4. To continue working with CCC on program-to-program curriculum articulation agreements that specify for CCC transfer students the CCC courses that satisfy major requirements required for degree completion at YCP.

OBLIGATION OF CARROLL COMMUNITY COLLEGE

To facilitate the transfer of CCC graduates to YCP in accordance with the foregoing, CCC agrees to the following:

1. CCC agrees to publicize this agreement to prospective and current CCC students in its promotional literature
2. Make arrangements for YCP recruiters and advisors to visit CCC on a mutually agreed upon regular basis
3. To continue working on program-to-program curriculum articulation agreements that specify for CCC transfer students the CCC courses that satisfy major requirements required for degree completion at YCP.

JOINT OBLIGATIONS

To facilitate the transfer of CCC graduates to YCP in accordance with the foregoing, CCC and YCP jointly agrees to the following:

1. Both YCP and CCC will review this Agreement on a regular basis and make any changes upon mutual agreement, as needed.
2. Students are required to graduate from CCC with a minimum GPA of a 2.0. Courses with grades of "C" or better will be brought into YCP as transfer credits.
3. To collaborate in providing students with information and academic advising both from YCP and CCC.
4. To jointly agree to develop and implement advertising and promotional efforts to communicate the benefits of Guaranteed Admission transfer.
5. To exchange data and documents on a regular basis that will contribute to the maintenance and improvement of the arrangement, enhance the transfer process, and promote effective cooperation

between institutions. These will consist of data about individual transfer students, including admissions information and grades, and reports on the results of program reviews, assessments of students' learning, and decisions of curricula and other committees.


6. To provide, when available, direct links between the YCP and CCC websites when applicable.
7. Either institution may terminate this Agreement at any time by written notice at least one year in advance of the effect date of termination. Should this Agreement be terminated, it is understood that the termination will not apply to students already accepted to YCP under the terms of this Agreement.
